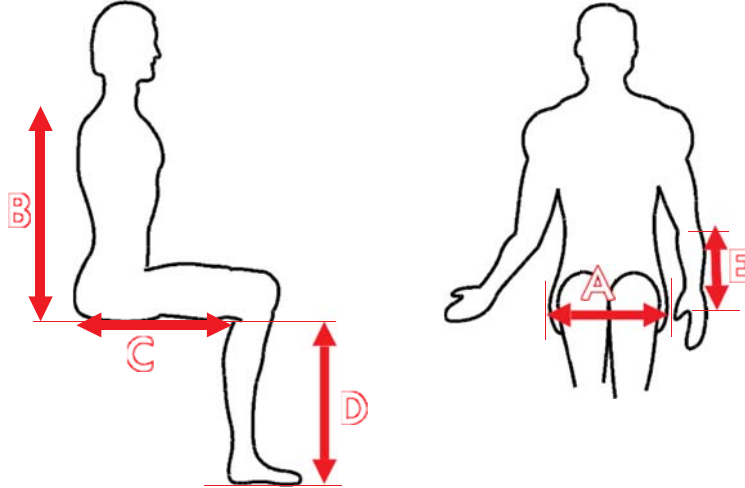

## **Information Memorandum on the Processing of Personal Data pursuant to Article 13 of Regulation (EU) 2016/679**

### **1. Who is the data processing controller?**

Freerider Sport Events A.S.D. with registered office at 5 Via Dandolo -21100 Varese, in its role as data processing controller (hereinafter referred to as, "**Company**" or "**Controller**") provides the information memorandum below related to the processing of the subject's data (as defined herein) for the purposes related to participation in promotional events organized by the Controller (hereinafter referred to as "**Events**").

### **2. To whom does the privacy information memorandum apply?**

This information memorandum applies to all subjects who take part in Events (all the subjects identified above are jointly defined and referred to as a "**Subject**").

In the event that a Subject provides personal data of any third parties, then said Subject shall be committed to notify such third parties of the content of this information memorandum, even by reference to the Privacy section of the <https://www.monosci.it/privacy> internet site.

### **3. What data is processed?**

Processing as intended in this information memorandum relates to personal data of a Subject that is collected during Events (jointly defined and referred to as "**Data**").

Data includes personal identification and contact information ( e.g. name, surname, email address, telephone number, residential address, date of birth, etc.).

### **4. For what purpose is the Data processed?**

The Subject's Data will be processed in accordance with the Law applicable to the processing of personal data for the following purposes:

- a) for completing the procedures for taking part in the events and for checking the correct fulfilment of the obligations provided therein;
- b) for administrative, accounting and tax purposes;

### **5. On what basis is the Data processed?**

Data processing is **mandatory** for pursuing the above mentioned objectives as refusal to provide Data would prevent participation in the Events and/or make it impossible for the Events to take place.

### **6. How will the Data be processed?**

In relation to the above purposes, Data processing will be carried out both with the help of IT or in any case automated tools, and on paper, and in any case using tools that are suitable for guaranteeing security and confidentiality of the data.

## **7. To whom is the data disclosed?**

The Subject's Data may become known to data processors, or rather the internal managers in charge of managing the Events.

For the purpose of carrying out an Event, the Subject's Data may also become known to parties located within the European Union, in such parties' capacity as external data processors or, in those cases where the applicable legal conditions subsist, in their capacity as autonomous data controllers, in the following categories: public or private parties, including independent professionals, bodies or consortiums, suppliers of tools or services to support the data processing Controller (and therefore, by way of example but not limited to, companies that provide IT services, technical experts, consultants, attorneys, auditing companies), associations, bodies, public administrations, companies that control or are under the control of or under common control as the data processing Controller, company or business line assignees, companies formed as a result of merger, split or other corporate transformation operations of the data processing Controller, external organizations responsible for carrying out activities that are linked with or a result of Events being carried out, credit institutions for the purpose of making payment orders or other financial services that are strictly instrumental for an Event to take place.

## **8. Is the Data transferred abroad?**

The Data may be freely transferred outside the national territory to other countries in the European Union. Any transfer of the Subject's Data to foreign countries even outside the European Union may take place whenever rendered necessary to pursue Contractual objectives, in particular with reference to the transfer of Data to the group parent company or to other companies that are controlled by, under the control of or under common control as the data processing Controller, or in the event that the data processing Controller decides to relocate its servers or company databases outside the European Union or to outsource services to third parties located abroad. Such transfer shall in any case be made in compliance with the appropriate guarantees as provided by the applicable law.

The Subject shall have the right to obtain a copy of the data held externally and to obtain information regarding the place where such data is kept by express request to the Data Processing Controller at the address indicated in Paragraph 9 of this information memorandum.

## **9. What are the Subject's rights?**

Without prejudice to the Subject's right not to confer his or her Data, and without prejudice to the effects of the preceding Paragraph 5, the Subject may at any time and free of charge: (i) obtain confirmation of the existence or otherwise of Data concerning him or her; (ii) be informed of the source of the Data, the purpose of the data processing and the methods used, the logic applied to the processing conducted by electronic means; (iii) request that his or her Data is rectified or - if interested - consolidated with other data concerning him or her; (iv) have any data that may be processed in breach of the Law deleted, transformed into an anonymous form or blocked, and to object to further processing on legitimate grounds.

The Subject may also at any time:

- i. request the Company to restrict data processing in the event that (1) the Subject contests the accuracy of the Data, for a period enabling the Company to verify the accuracy of such Data; (2) the processing is unlawful and the Subject objects to the erasure of such Data and requests the restriction of its use instead; (3) notwithstanding the fact that the Company no longer needs the Data for the purposes of the processing, the Subject requires the Data for the establishment, exercise or defence of legal claims; (4) the Subject has objected to processing pursuant to Paragraph 1 of Article 21 of the Privacy Regulations pending the verification whether the legitimate grounds of the Controller override those of the Subject;



- ii. object at any time to the processing of his or her Data for purposes of legitimate interest;
- iii. request the deletion of Data that concern him or her without undue delay and
- iv. to have such data ported (to another party).

Lastly, the subject will have the right to lodge a complaint with the Data Protection Commissioner where the conditions to do so exist.

It is understood that the Subject shall have the right to lodge a complaint with the supervisory authority where the conditions to do so exist.

### **10. How long is the Data stored?**

The Data collected pursuant to the preceding Paragraphs 1 and 3 shall be kept for a period which includes the term of the relationship plus 10 years following the termination of the relationship, with due exception for those cases where there is a requirement for such storage period to be extended due to disputes, by request of the competent authorities or pursuant to applicable Law.

Upon expiration of the storage period the Data will be deleted, rendered anonymous or (statistically) aggregated.

### **11. Modifications and updates**

This information memorandum shall be applicable as from the date on which it enters into force. The Company may however, make changes and/or additions to the information memorandum which will be appropriately notified.

### **Information memorandum on the use of photographic, video, advertising and similar material**

The use of photographic, video, advertising and similar material defined as "media material":

- Publication of media material, both on paper and via ICT services, for initiatives linked with the Company, including by way of example, posters, billboards, newsletters;
- Publication of "media material" via internet including the use of platforms that allow the distribution of images and videos such as, by way of example, Instagram and You Tube;
- Production and transmission of "media material" using any means, even with the help of associates and specialized external companies (e.g. ICT companies, telecoms companies, etc.), to whom technical and organizational tasks may be assigned. These third parties will carry out their tasks in accordance with the instructions and security procedures that the Company has defined to fully protect its confidentiality. These parties carry out their tasks in their capacity as data processing "processors" or "Controller's appointee" or, in those cases where the Law permits, they operate as distinct data processing "Controllers";
- grant or transfer to the Teleflex company, both in Italy and abroad, the "media material".
